AGREEMENT FOR REPAYMENT TERMS
OF THE WASTE TO ENERGY PROJECT LOAN

THIS AGREEMENT made this ____ day of _____, 2021.

OF THE SECOND PART

WHEREAS the County agreed to provide up-front capital funding in the amount of One Million, Two Hundred Fifty-Five Thousand (\$1,255,000.00) Dollars to the PRWMC for the purpose of the construction of a Waste to Energy (WtoE) project on June 23, 2020.

AND WHEREAS the County and the PRWMC agree to enter into a 10-year payment plan including interest (1.65% compounded annually) for the costs associated with the WtoE repayable by the PRWMC to the County as per Schedule A.

AND WHEREAS payments to the County by the PRWMC will begin by December 31, 2021 and will continue annually by December 31 in subsequent years for a period of ten year.

AND WHEREAS the last payment to the County by the PRWMC for the funds is to be paid on or before December 31, 2030.

AND WHEREAS the other two municipal partners of the PRWMC being the Town of Peace River and the Village of Nampa will agree to provide funding to the PRWMC to financially assist the PRWMC if they are not able to meet the payments required within that 10-year timeframe in proportionate partner share amounts as per Schedule B.

AGREEMENT FOR REVOLVING OPERATING LINE OF CREDIT

OF THE FIRST PART

(hereinafter called "PRWMC")

OF THE SECOND PART

WHEREAS the County will provide a Two Million (\$2,000,000.00) Dollars revolving operational line of credit (OLOC) to the PRWMC for the purpose of financing general operating requirements.

AND WHEREAS the PRWMC may borrow, repay and reborrow up to the amount of this revolving OLOC on an as needed basis to meet financial operating expenditures.

AND WHEREAS the interest rate will be 1.65% compounded annually on December 31 OR on an average monthly balance over the course of the year; OR *the lesser of* on the amount of the OLOC that has been used as at that date.

AND WHEREAS there is a monthly payment, due on the last day of each month of no less than five (5%) percent including interest of the extended OLOC.

AND WHEREAS the PRWMC will provide written documentation to each municipal partner, Northern Sunrise County, the Town of Peace River, and the Village of Nampa once the OLOC has been expended more than One Million Five Hundred Thousand (\$1,500,000.00) Dollars.

AND WHEREAS the Town of Peace River and the Village of Nampa, as municipal partners of the PRWMC agree to provide funding in proportionate partner share amounts to the PRWMC to financially assist the PRWMC if they are not able to meet the required monthly payment after a period not to exceed six (6) months, and the OLOC has reached the maximum threshold of \$2,000,000, as per Schedule A.

North Peace Housing Foundation Board Meeting Synopsis – July 7, 2021

COVID-19 Update

Alberta's move to Stage 3 on July 1, 2021, does not change requirements highlighted in the existing public health orders for Lodge settings. Stage 3 will impact activities off-site, but existing on-site restrictions will remain in place at this time.

Expectations of residents

- It is recognized that residents may want to leave the facility property to use community services.
- Residents must remain vigilant in their actions to protect themselves and others.
- Should a resident choose to go off facility property the resident is responsible to:
 - Maintain physical distancing of 2 metres.
 - Wear a mask at all times.
 - Maintain good hand hygiene.
 - Be screened upon re-entry.
 - Be aware of any risk of exposure to COVID-19.
 - Understand any precautions that may be required upon their return (self-checks and masking when outside of their room).

Visiting policy

- Each resident or alternate decision maker may identify up to 4 designated family/support persons who are essential to maintaining resident mental and physical health.
- Multiple residents may continue to have the same designated family/support persons.
- Outdoor social visits may include up to 10 people, including the resident, where space permits.
- Where possible, indoor social visits with up to 4 visitors may resume if the majority of residents agree to these changes.
 - Visitors must be from the same household.
 - Physical distancing, masking and other safety measures must be followed.
 - Designated family/support persons are not required to be present for indoor or outdoor visits from others.
- Visitors will continue to be able to visit when residents are approaching the end of their lives or suffer a change in health status.

The extent of these changes may vary by site, based on the design of the building, wishes of residents, and other factors.

Any visitor with symptoms of COVID-19 or known recent exposure to COVID-19 will not be permitted entry into the Lodge. All visitors should understand their risk of unknown exposure to COVID-19 and take steps to protect

residents and staff, including consistent hand hygiene practices, physical distancing and wearing a mask indoors, and follow all related facility rules.

On June 30, I took part in a Town Hall regarding the lifting of restrictions in Lodges and other Health facilities and at that time, Dr. Hinshaw stated that they would be taking a 2 phased approach. Phase 1 may be as early as mid-July and will include the continuation of outbreak prevention protocols including:

- Masking
- 2x sanitizing of high touch surfaces
- Health Screening
- Quarantining requirements for non-vaccinated individuals coming from a facility in outbreak status
- Residents will continue to be encouraged to remain vigilant and visitors will be asked to stay home when sick.

We anticipate further on-site relaxing of restrictions for those fully vaccinated (details of which have not been disclosed at this point).

The restrictions are being lifted at a slower rate in Lodge because our residents are more susceptible to negative outcomes in the event of illness. We need to ensure that increased community numbers do not translate into our facilities.

Additionally, it looks as though symptom screening and masking will be ongoing, longer term.

Seniors Self-Contained (SSC) Apartments

The tenants of the SSC apartments, like all other Albertans, are no longer restricted in their activities. We have opened all common areas and are in the process of returning furniture to their original locations. We are continuing with the sanitizing of high touch surfaces in the common areas as much as staffing will allow until we have a better idea of where the community transmission rates will be in the upcoming weeks.

Central Office

We are slowly starting to transition back to normal operations at Central Office. We do have some individuals who have come back to the office this week, more will be in office next week, and there are a few Directors who will continue with a hybrid work schedule.

Masking while in the office is no longer mandatory, but we are supportive of anyone who chooses to continue to wear a mask. PPE is regularly available on site, as are sanitizing wipes, spray, and hand sanitizer.

We continue to encourage proper hand hygiene and regularly sanitize high touch surfaces. We will not be taking down the protective barrier at the front reception area and feel that it will be up long term.

We do not anticipate that our client interaction will change over the upcoming months as many of our tenants pay their rent by e-transfer and most other interactions are by appointment. Typically, we see the tenants of Garden Court more than most, because they reload their laundry cards. Foot traffic really is at a minimum.

Nominal Sum Properties

We continue to receive calls from interested individuals and have shown the properties in Grimshaw, Berwyn, and Blue Sky. We have received an unofficial offer on one of the units in Berwyn.

West View Condominium Project

We have started our research on focus groups/community consultation and RFP's dealing with such. This continues to be on our list of priorities.

Del Air Redevelopment

We have been presented with an updated draft of the pre-award document and are working through areas that require further clarification. The Geotechnical and Surveying contracts have been awarded and work/mobilization was scheduled for June 22 – 24, 2021. The Geotechnical report should be available approximately 4 weeks upon completion of drilling. The site survey plan should be ready by the week of July 6.

General

Heritage Tower HVAC System Replacement

We have submitted a revision to our original budget request and presented a phased approach to the replacement of the HVAC system; however, we have yet to receive confirmation that our request has been approved.

ASCHA Promotional Video

The filming of our promotional video took place from June 21-24th, 2021. Our Director of IT, Communications and Stakeholder Relations, Don Good, spent the 4 days with the Videographer touring our Lodges and different Senior Self-Contained and Family Housing properties. We are very excited to see the finished product, as several resident, tenant, and staff interviews were filmed. We had beautiful weather throughout the filming, and everything was lush and blooming after the rainfall the previous week.

Resident and Tenant Levels

As of the end of May 2021, we had a total of 159 lodge residents, consistent with the Month of April. Our lodge unit occupancy at the end of May was 69% of the 224 lodge units occupied.

We had 115 occupied Senior Self-Contained units at the end of May, down 1 from the month of April. Our occupancy rate at the end of May was 88%. Garden Court Seniors Apartments had 57 of the 63 units occupied at the end of May, consistent with the month of April; our occupancy rate was 90%. We continued to have 5 out of the 8 trailers in Cadotte occupied at the end of May.

The Family Housing program had 80 of the 123 units occupied, up 3 from the previous month, and 20 of the 38 Rural units occupied, consistent with the month of April, with an overall occupancy of 62%. We had 32 Rent Supplement recipients in the month of May, consistent with the month of April.

The Rent Assistance Benefit (RAB), formerly the Direct to Tenant Rent Supplement, is a long-term benefit which will continue to subsidize the rent for Albertans with low income. Households are eligible if they are below local income thresholds; subsidy amounts are calculated based on household income and local market rent.

The previous Private Landlord Rent Supplement is not reopening for new applications. Current recipients will be transitioned to the Rent Assistance Benefit, as funding agreements for those units expire.

Board Decisions

The Board has directed that Administration start the process required to replace the Heritage Tower Lodge air handling unit, the makeup air unit and domestic hot water tank as soon as possible at the estimated cost of \$599,660.00, unless directed otherwise by Capital Maintenance.

The Board approved the roofing and eavestroughing replacement for 2 single family homes, one in Grimshaw and one in Fairview in the amount of \$9,480.00 plus GST, with Rick Dostaler Construction as the approved contractor.

The draft Strategic Plan was presented and accepted as information.

The Board has directed that Corporate Policy 2.2 Vehicle Policy be accepted as presented and that Corporate Policy 2.7 – Disposal and Sale of Assets be accepted as amended.

Re: Bill C-21 – Changes to the Criminal Code and the Firearms Act

On behalf of the Municipality of Crowsnest Pass, we are writing to express our concerns with respect to Bill C-21 to make changes to the Criminal Code and the Firearms Act. With respect to the provision to allow municipalities to create handgun bylaws, which would place conditions on federal firearms licenses relating to handgun use, storage or transportation within municipalities that have passed such bylaws, Council has passed the following motion at the June 8th meeting of Municipal Council in opposition to the Federal Bill C-21:

16-2021-06-08: *Councillor Sygutek moved that the Municipality of Crowsnest Pass is opposed to the adoption of any bylaws restricting the possession, storage, and transportation of legally obtained handguns, and that Administration write a letter to Prime Minister Trudeau with similar information as provided by Kingsville, Ontario which will be copied to all Alberta municipalities, MP Shannon Stubbs, MP John Barlow, and to the Leader of Official Opposition Erin O'Toole. Carried*

With the Province of Alberta sending Bill 211 to Royal Assent on April 29th, our Provincial government is ensuring that Municipalities are not saddled with trying to find the resources to impose or enforce gun control by creating inconsistent bylaws between jurisdictions. As most Municipalities across our province are rural in nature and would be faced with the same problems in attempting to enforce legislation of this nature, we are anticipating that the sentiment will be the same across most jurisdictions and hope that those municipalities in opposition will make their position known to the Federal Government as well.

We are also concerned that Bill C-21 is only targeting citizens that have licenses, not criminals that have already obtained firearms illegally and would never comply with a municipal bylaw. This will create a very confusing system that could result in an otherwise law abiding citizen, now being sentenced to two years imprisonment or permanent license revocation for unknowingly being in contravention of a bylaw in a community with different bylaws.

We thank you for your kind attention in this matter and request that the federal government will reconsider these changes to the Criminal Code and Firearms Act.

It should be up to the provincial and federal governments to deal with any shortfalls, and not to overload municipalities with further monetary strain.

At the last regular meeting of Claresholm Town Council held Monday, July 19, 2021, Council discussed the Councillor Codes of Conduct instituted by the Alberta Government on October 26, 2017. It has been brought to our attention by the Alberta Urban Municipalities Association (AUMA) that the current Alberta Government has plans in the works to remove the requirement for municipalities to have a Code of Conduct in place to govern all Councillors equally by way of Bylaw.

The Town of Claresholm passed Bylaw #1641, the Council Code of Conduct Bylaw on April 9, 2018 prior to the government's deadline of July 23, 2018. In the current Council's first year of governance, it became inherently clear how important a Councillor Code of Conduct is, as our Council had to undergo advanced communication training and contract outside mediation to overcome some contentious issues.

Claresholm Town Council respectfully requests that your ministry tread this path lightly and make sure that consultation with municipalities in Alberta is completed prior to any major changes being made. The Alberta Urban Municipalities Association should be highly involved, and the Town of Claresholm fully supports their efforts. Having a requirement for municipalities to have a Code of Conduct Bylaw in place provides a framework for Council members' behavior and provides each Council direction and guidance for dealing with any contentious issues that may arise. It is imperative that the option of imposing sanctions on Council members continues as necessary to support this process. Claresholm Town Council requests that the Council Code of Conduct Bylaw requirement remains in place.

I am pleased to confirm that Alberta will receive \$499 million in funding under the federal Gas Tax Fund (GTF) in 2021. This includes an additional one-time payment of \$244 million announced by Canada in March 2021 in recognition of the critical role our communities play in a safe restart, and to help reduce the risk of infrastructure projects being delayed or cancelled. This additional funding is intended to help municipalities and Metis Settlements address local infrastructure needs, and must follow all rules and conditions of the GTF program.

For the Village of Nampa:

- The **2021 GTF allocation is \$100,000**. This includes \$50,000 as a result of the one-time funding top-up.

GTF funding amounts for all municipalities and Metis Settlements are also posted on the Government of Alberta website at open.alberta.ca/publications.

In addition, the federal government announced that the GTF program is being renamed to the Canada Community-Building Fund to better reflect the nature of the program. Over the coming months, Municipal Affairs will be updating program documents, websites, and IT systems to reflect this change.

I look forward to working together with you and the federal government to help your community in addressing its infrastructure needs.

SUBJECT: Canada's transition to Next Generation 9-1-1 Service

Dear Ms. Roshuk,

On June 1, 2017, the Canadian Radio-television and Telecommunications Commission ("CRTC") issued Telecom Regulatory Policy 2017-182: *Next-generation 9-1-1-Modernizing 9-1-1 networks to meet the public safety needs of Canadians*, setting out its determinations on the implementation and provision of NG9-1-1 networks and services in Canada and its view that such a transition would provide Canadians with access to new, innovative emergency services and capabilities.

In support of its decision, the CRTC has ordered TELUS, Bell and SaskTel to build NG9-1-1 networks to replace the existing 9-1-1 network to support each company's operating territory. The decommissioning of the existing 9-1-1 network is currently set by the CRTC to occur on March 4, 2025. To this end, TELUS is set to launch the NG9-1-1 network on March 1, 2022 and can begin onboarding Public Service Access Points ("PSAPs") and the respective municipalities they support soon thereafter.

In preparation for the NG9-1-1 transition, TELUS will need to update all current Local Governing Authority ("LGA") Agreements for 9-1-1 with NG9-1-1 Agreements. Securing new NG9-1-1 LGA Agreements is a critical landmark as the signing of these agreements will allow PSAPs to migrate onto TELUS' NG9-1-1 network. It is also important to note that from a technical and operational perspective, to onboard a PSAP to the NG9-1-1 network will require that all the municipalities and First Nations and Metis governments it serves to have signed the NG9-1-1 LGA with TELUS.

TELUS is looking forward to working with local municipalities, First Nations and Metis governments, and PSAPs to support this exciting initiative that will enrich the public safety of Canadian citizens. We kindly ask for your cooperation in **identifying your prime contact and representative for NG9-1-1 matters, by August 11, 2021**, so that we may keep you informed.
