Dear Village of Nampa CAO,

The 2021-2022 school year is the 24th consecutive year of Safety Smarts delivery to children attending rural and remote elementary schools in Alberta. The generosity of many continues to make this unique farm safety extension effort possible and we are grateful for each and every dollar donated in support of the important outreach of our charitable organization.

As you know, this past year was filled with unique challenges related to the Covid pandemic. However, we have managed to keep both our Safety Smarts and our Sustainable Farm Families programs running albeit in a slightly different fashion than in previous years.

The Safety Smarts program has been adapted to allow for both virtual delivery via Zoom as well as safe face-to-face delivery in schools. Our Safety Smarts team has been well trained and fully equipped with all the necessary skills and tools to be able to successfully and safely deliver Safety Smarts presentations to rural elementary students across the province. In the 2021 calendar year, our Safety Smarts team delivered a total of 1,586 Safety Smarts presentations to 31,330 elementary students in 285 rural elementary schools across the province.

The Sustainable Farm Families program, also known as the Rural Health Initiative, is a newer program designed to promote health, well-being and safety to rural adults. In 2021, the Sustainable Farm Families program made significant adaptations to allow for one-on-one in-depth health assessments and personal education instead of the traditional group setting. This new approach has enabled us to safely deliver Rural Health Initiative workshops within the current Covid restrictions. More information about the Rural Health Initiative is attached. Please let us know if your organization would like to host a Rural Health Initiative workshop for families in your area.

You may also know, that in October of 2020, the Farm Safety Centre was informed by Government of Alberta representatives that <u>ALL</u> their involvement in and support of farm safety learning and extension would end in December 2020. True to their word, their departmental staff were laid off and online resources were withdrawn at the end of 2020. This has created a significant funding challenge for the Farm Safety Centre and other agriculture based charities in the province that care about the well-being of farmers and their families. To put into perspective, about 35% of our annual funding came from the GOA in the form of government grants designated for program delivery.

With this in mind, the Farm Safety Centre is hopeful that in 2022 your organization will consider supporting our extension efforts, as we continue the search for alternate funding partners. As budget realities allow, we invite the Rural Communities in Alberta to consider a modest 2022 donation of \$150 - \$350. If this is does not work within your budget then a donation of any amount will be greatly apricated.

As a charity registered with CRA, any donation in support of our mission is eligible for a charitable tax receipt.





Research into the state of rural health has identified several health and well-being disadvantages faced by rural people which negatively impact their quality of life. The Sustainable Farm Families Rural Health Initiative aims to remedy many of these disadvantages by providing rural Albertans who participate in this program with 3 annual, in-depth physical & mental health assessments. In addition to these health assessments, participants are educated about each aspect of the assessment to ensure they fully understand each of their measurements and know how to better manage their health and well-being. Those who participate in this program are only asked to commit 1 hour of their time each year over the course of the 3-year program.

The preventative approach used by the Sustainable Farm Families Rural Health Initiative takes seemingly healthy people living in rural communities and seeks to either uncover undiagnosed conditions or confirm their healthy status. Since 2014, the Farm Safety Centre has delivered over 135 SFF workshops to more than 1,300 participants across the province. Participant feedback from our external evaluations have identified that 97% of SFF participants felt the workshops were a good investment of their time and that 92% recommended the program to others.

RE: Renewal of Agreement for Property Taxes

The agreement for reimbursement for a portion of the property taxes that would normally be charged to the Nampa Co-op Seed Processors expired on November 30, 2021. The board of directors of the Nampa Co-op Seed Processors would ask your Council's consideration to renewing into a similar agreement for the duration of your term (four years).

The proposed amount for 2022 is \$5,520 which would be an increase of 2% from 2021. An additional increase of 2% would ensue for the remaining years of the agreement, as is was in the previous agreement.

The investment into a new seed cleaning plant for our area was made possible through the collaboration of local governments, and the board would like to extend its gratitude for their ongoing support.

FAMILY & COMMUNITY SUPPORT SERVICES (FCSS)

YOUTH PROGRAMMING

BABYSITTING COURSE

In 2021, Nampa/Northern Sunrise County Community Services offered a babysitting course in St. Isidore for youth between the ages of 11-15. The Canadian Red Cross Babysitting course covers everything from managing difficult behaviours to essential content on leadership and professional conduct as a babysitter. Babysitting deepens and enhances the responsibility that older youth feel when caring for younger children.

KIDS EXPLORERS

Kids Explorers aims to connect youth in the community of Cadotte Lake. The program is geared towards school aged children. Participants enjoy a variety of crafts, games, activities, team building initiatives and receive light snacks and refreshments.

KIDZ KONNECTION

Kidz Konnection aims to connect youth afterschool in the community of Nampa. The program is geared towards school aged children. The youth participate in a variety of themed crafts, games, activities, team building initiatives and receive light snacks and refreshments.

PARENTING PROGRAMS

In 2021 we offered parent and tot based programs in Nampa (Little Adventurers), St. Isidore (La Petite Ecole) and in Three Creeks and Marie Reine area (Parent Pit Stop). These programs allow parents to learn how to play with their child and how to enhance early development skills. Parents and their children were able to explore different themes (St. Patrick's Day, Green means Go, Bloom & Wild, Wild West, Earth Day, Welcome to the Jungle, Picnic in the Park, Nuts & Squirrels, Pumpkin Pie, Dynamite Dino's).

TEEN CRAFT CONNECT

In 2021, a Teen Craft Connect program was established to reconnect the teens in the community of St. Isidore. The teens came together with local artisans to make natural-based bath bombs and sugar scrubs as well as personalized keys chains and custom wood signs featuring positive affirmations. The program was made possible in partnership with Greenwood Hobbies and the Green Goddess.

TINKER BAGS

Tinker Bags were designed by Cadotte Lake Community Services to enhance children's fine motor skills and to keep them mentally active while at home. The program is geared towards children ages 0-6 and their parents. In 2021, the tinker bag themes included Valentine's Day, Rock Painting, Sunshine & Rainbows, Birdhouse Painting, and Fairy & Dino Gardens. Participants received a variety of themed crafts and activities to complete as a family, which were made available for pick up at the Mamowintowin Hall.

TINY CHEFS

The Tiny Chef's program was introduced in the community of Cadotte Lake in 2021. The goal of the program is to encourage families to come together with their children to cook a healthy meal. Cooking kits, which included all of the ingredients required to participate and recipes, were provided to registered families as well as a Zoom link to join the chef virtually. The Tiny Chefs program was coordinated in partnership with Woodland Cree Health and KTC Health.

YOUTH SUMMER CAMPS

In 2021 Nampa Community Services coordinated two summer camps for children ages 6-9. Busy Buddies was coordinated in July. Participants enjoyed three days of exploring the Peace Region (Tangent Park, Strong Creek, River City Cinema, and the EastLink Centre).

Feisty Friends was coordinated in August. Participants enjoyed three days of exploring the Peace Region (Saddleback Playground, Tapped Out Gaming & Entertainment, Peace River Splash Park, High Prairie Aquatic Centre, Marie Reine Sports Court and Murphy's Flats).



FAMILY & COMMUNITY SUPPORT SERVICES (FCSS)

COMMUNITY PROGRAMMING

ADULT LEARNING OPPORTUNITIES

In 2021, Nampa/Northern Sunrise County Community Services partnered with a variety of local and regional organizations to offer free adult learning opportunities. Presentations made available included Managing Stress, Anxiety Explained, Mental Health Awareness, Mental Health First Aid, and Calming & Creative Colouring. The goal of the adult learning opportunities is to link individuals to local resources, increase their knowledge around mental health and engage participants in conversations.

BLANKET EXECISE

In 2021, Nampa/Northern Sunrise County partnered with Peace River Aboriginal Interagency and the Nampa & District Museum to host the KAIROS Blanket Exercise, using localized script. The KAIROS Blanket Exercise is an interactive and experiential three hour workshop, which teaches Indigenous history through an Indigenous lens. Facilitators guide participants through a summarized version of historic events from precontact to colonization, up to how colonialism continues today, and its impact on all of us. The KAIROS Blanket Exercise training supports both the Truth and Reconciliation Commissions (TRC) and UN Declaration calls for action for governments to help public servants understand how colonization impacted people who lived here long before 1492. The KAIROS Blanket Exercise shows that we are together on this journey of reconciliation.

BUDDY UP CAMPAIGN

In 2021, Nampa/Northern Sunrise County registered for and coordinated the Buddy Up Campaign during the month of June. Buddy Up is a men's suicide prevention communications campaign; a call to action to men, by men. For the month of June, posts revolving around suicide, men's health, and having open, honest conversations with men were shared on the County and Community Services social media pages.

CHRISTMAS GIFT CARD PROGRAM

Each December, Nampa/Northern Sunrise County Community Services receives donations from local organizations and individuals to purchase Christmas Gift Cards for those in need. Since 2014, gift cards have been purchased from local grocery stores and delivered to people in need through the mail in a Christmas card. The program is 100% anonymous. Community members are encouraged to refer those in need to the Community Services Department so that they are included on the Christmas Gift Card program list. In 2021, there were 87 families and individuals that received a gift card and Christmas card in the mail courtesy of donations received from Northern Sunrise County, APL, the Proud Family, Macmillan Construction, Nampa Gospel Women's Ministry, Boucher Brothers, the Village of Nampa, and a variety of anonymous individual donors.

COMMUNITY PANTRY PROGRAM

Nampa/Northern Sunrise County Community Services has food shelves at their local office spaces to assist with collecting and dispersing non-perishable goods to individuals and families in need. The Community Pantry Program aims to assist individuals experiencing financial hardships.





FAMILY & COMMUNITY SUPPORT SERVICES (FCSS)

COMMUNITY PROGRAMMING

BLANK CANVAS: ART & MENTAL HEALTH

Cadotte Lake Community Services partnered with Woodland Cree First Nation and KTC Health to offer free virtual paint nights, which included engaging conversations surrounding common mental health concerns, such as anxiety, depression, suicide, etc. Registered participants received the art supplies required and a Zoom link to join the paint instructor. While painting, participants were provided resources and information on mental health and given the opportunity to share their lived experience and their current struggles.

DR. UNGAR PRESENTATIONS

Creating Strength Through Crisis

Nampa/Northern Sunrise County Community Services partnered with the Town of Peace River and Project Peace to host a virtual presentation with Dr. Ungar in March 2021. In this presentation, Dr. Ungar discussed how to foster resiliency through strong connections with family and community.

Nurturing Resilience Through Strong Community

Nampa/Northern Sunrise County Community Services partnered with the County of Northern Lights and Manning FCSS to host a second virtual presentation with Dr. Ungar to further explore resiliency in August 2021. In this presentation, Dr. Ungar revealed that resilience is much more than our personal capacity to overcome adversity. It is instead a reflection of how well individuals, families, employers and communities work together to create opportunities for people to navigate their way to the resources they need for well-being, while making those resources available in ways that people experience as meaningful.

E-PREP

In November 2021, Nampa/Northern Sunrise County Community Services partnered with Alberta Health Services Mental Health to host E-Prep virtually, a two hour interactive presentation on how to develop a personalized emergency preparedness plan.

FAMILY DAY CELEBRATIONS

A Family Day celebration is held annually in the communities of Cadotte Lake & Nampa. The Family Day event allows families to reconnect with one another. Due to the restrictions in place during Family Day, family activity kits were developed for distribution in these communities.

Cadotte Lake Community Services coordinated a pizza and game night kit for families. The kits included supplies to make a pizza from scratch and a board game to play as a family.

Nampa Community Services coordinated Family Day Grab Bags which included a variety of activities for families to play at home, an outdoor scavenger hunt, an ice balloon project, hot chocolate, popcorn, and honey snow candy supplies, which included honey from MCW Apiaries.

GET TO KNOW FCSS S'MORE

In 2021, Nampa/Northern Sunrise County Community Services hosted an outdoor gathering at Cecil Thompson Park to inform community members about FCSS programs and services and to meet committee members and the staff. In addition to the resources available, a local musician was on site to provide acoustic music and a door prize was made available to those who submitted a feedback form.

THE GIVING TREE PROGRAM

Nampa/Northern Sunrise County Community Services accepts donations of new and/or gently used mittens, toques, and coats during the months of November and December. Items received were dispersed to community members in need and to local agencies supporting individuals experiencing hardships and/or homelessness.



FAMILY & COMMUNITY SUPPORT SERVICES (FCSS)

COMMUNITY PROGRAMMING

HOME ACTIVITY KITS

In response to the pandemic, Nampa/Northern Sunrise County Community Services offered a variety of pick up and drop off style activity bags to assist families when in-person programs were not permitted. Kits offered included Indoor Herb Kits, DIY Sign Kits, Sundae Funday Kits, Hoppy Easter Kits, Photo Frame Decorating Kits, and Gingerbread Decorating Challenge Kits.

INTERNATIONAL WOMEN'S DAY BEAUTY & SELF CARE KITS

In celebration of International Women's Day, beauty and selfcare bags were made available to women ages 18 and older. The bags included bath bombs, lip balms, manicure sets, local resources, and activities to improve mental health.

KINDNESS CAMPAIGN

The Random Acts of Kindness Calendar Campaign was open to everyone. Participants were encouraged to print or screenshot the Kindness Calendar and share their completed random acts of kindness for a chance to win 1 in 5 kindness themed prize packs. A kindness themed colouring contest was also coordinated in conjunction with the campaign. The goal of the campaign was to get people actively participating and spreading some additional kindness within their communities.

LET'S GROW TOGETHER

In celebration of Mother's Day, Mother figures and their children were invited to a paint and plant event. Due to poor weather, participants received a kit to paint their own pots and strawberry plants from Ferns Greenhouse.

NOEL ST. ISIDORE

In 2021, St. Isidore Community Services partnered with the St. Isidore Cultural Centre to host a Christmas Tree Light Up event at the local church grounds. Participants enjoyed hot chocolate, hot dogs, and music.

PSYCHOLOGICAL FIRST AID FOR A PANDEMIC

In 2021, two Psychological First Aid (PFA) courses were offered virtually; January and December. PFA is considered to be the first stage intervention during a disaster or emergency. During a pandemic, response looks different but the principals are similar. PFA online training allows responders to provide support over the phone to individuals that may be quarantined, in self-isolation, or practicing physical distancing in order to prevent the spread of a pandemic. PFA is a two hour interactive online training which covers essential tools, key PFA action principles, and self-care for responders.





FAMILY & COMMUNITY SUPPORT SERVICES (FCSS)

COMMUNITY PROGRAMMING

SUICIDE PREVENTION

In 2021, Nampa/Northern Sunrise County Community Services partnered with Alberta Health Services to host virtual Suicide Prevention workshops:

Small Talk

Small Talk is an interactive half-day workshop which examines warning signs in a child and explores intervention strategies through stories and case studies.

Looking Forward

Looking Forward is an interactive half-day workshop created for individuals working with youth aged 12 to 24. Looking Forward encompasses the developmental, cognitive, and emotional differences found within this age group and presents strategies to strengthen the protective factors of youth considering suicide.

VOLUNTEER APPRECIATION

In 2019, Nampa/Northern Sunrise County Community Services implemented the Volunteer Appreciation Awards. Residents of Northern Sunrise County and the Village of Nampa are encouraged to nominate local volunteers in their communities. The Awards recognize County residents for their volunteer efforts and how they have contributed to the well-being of their community and fellow community members. Award categories include:

- Outstanding Volunteer Award Youth
- Outstanding Volunteer Award Adult
- Outstanding Volunteer Award Senior
- Penny Butz Volunteer Award (only Village of Nampa residents eligible)

In 2021, nine volunteers were recognized; Doug Campbell, Francois Allard, Nicole Proud, Bradyn Proud, Kaeden Krahn, Del Gardner, Frank Armella, Marie Dyck, and Dana Butz.

Due to the pandemic, the Volunteer Appreciation Gala was postponed in April and rescheduled to November. However, due to restrictions in place, the event had to be cancelled. To ensure that the volunteers were still honored, photos and a description of their contributions were displayed on social media platforms, local newspapers, the County website and radio ads were purchased.

VOLUNTEER INCOME TAX PROGRAM

The Volunteer Income Tax Program is for low income seniors (55 and older), persons with disabilities, and individuals with modest income.

In 2021, Nampa/Northern Sunrise County Community Services applied to host income tax preparation clinics for the Community Volunteer Income Tax Program with Canada Revenue Agency. The clinic ran from March 1—May 29, 2021 and it assisted 42 residents with completing their 2020 tax returns.













FAMILY & COMMUNITY SUPPORT SERVICES (FCSS)

SENIOR PROGRAMMING

HOME SUPPORT PROGRAM

The Home Support program was established to assist families and individuals, seeking to create an environment conducive to the clients needs. The service is designed to promote well-being in our region by providing assistance in the household; enabling ill, disabled, or frail individuals to remain in their own homes and to age in place.

In 2021, the Home Support Program had one casual Home Support Coordinator and six clients.

SENIORS' COFFEE MORNING & SENIOR CUP OF JOE ON THE GO

Seniors' Coffee Mornings were held in Nampa at the Farmers Restaurant. The coffee program allows seniors to connect with other seniors and enjoy a free cup of coffee or tea.

Nampa Community Services offers the Seniors' Coffee Morning on a bi-weekly basis. When restrictions were heightened, the Senior Coffee Mornings were adapted into Senior Cup of Joe on the Go, allowing seniors to grab a coffee to go. This gave seniors an opportunity to venture out of their house, get some exercise, and enjoy a free warm beverage.

SENIOR PAINT NIGHT WORKSHOP

Cadotte Lake Community Services hosted a paint night geared towards elders 55 and older. The workshop allowed seniors to learn a new skill while reconnecting with other local elders. Supplies, instruction and light refreshments were provided.

SENIOR SUCCULENT WORKSHOP

St. Isidore Community Services planned to coordinate a senior succulent workshop in-person. Unfortunately, due to the restrictions in place, the workshop was adapted into take home kits. Seniors received all the supplies needed as well as instructions on how to construct their own tabletop succulent garden.

SENIORS' WEEK EVENTS

Nampa/Northern Sunrise County strives to celebrate their seniors each year by hosting and attending Seniors' Week events throughout the Peace Region. Due to the pandemic, Seniors' Week looked a bit different again this year.

St. Isidore Community Services coordinated a Seniors' Week Strawberry Tea delivery program for the County and Village of Nampa residents. Participants received a a County swag bag filled with strawberry themed treats, including homemade jam.

Cadotte Lake and Nampa Community Services hosted a Seniors' Week Supper for the County and Village of Nampa residents. Participants received a hot supper, along with a potted flower. The program reached 120 residents; 20 from Cadotte Lake, 22 from Harmon Valley, 10 from Marie Reine, 12 from Nampa Rural, 14 from St. Isidore, 14 from Three Creeks, and 28 from the Village of Nampa.

WHEELS TO MEALS

The Wheels to Meals program provides nutritious meals and promotes health, well-being, and independence for individuals. The program is offered every Monday, excluding stat holidays. In response to the pandemic, the Wheels to Meals program remained available by delivery only and clients were invoiced on a monthly basis. In 2021, the program was offered 43 times, and it served 45 residents.



YOUTH PROGRAMMING

BAKING OVER THE FIRE

Cadotte Lake Community Services hosted a workshop for children & youth to learn how to make pizza over an open flame. Participants were provided the ingredients needed to make homemade pizza dough and were able to make their own individual pizza to enjoy.

BIKE RODEOS

In 2021, Nampa/Northern Sunrise County Community Services coordinated three Bike Rodeos. Bike Rodeos were held in Cadotte Lake, Nampa, and St. Isidore and were hosted in partnership with the local RCMP as well as the local Fire Departments. Bike Rodeos allow youth to learn valuable bike safety tips and gain confidence while riding in their communities. In addition to the Bike Rodeos, St. Isidore Community Services hosted a Bike Rodeo Video Challenge. The challenge encouraged youth to take a video of themselves practicing bike safety for a chance to win a door prize.

CRAFT WORKSHOPS

In 2021, Nampa/Northern Sunrise County Community Services coordinated several in-person crafting opportunities for children & youth. Craft workshops allow children & youth to come together with their peers to learn a new hobby and skill set. Supplies, instructions and light refreshments were provided to the participants. Workshops provided in 2021 were a Mother's Day Wood Sign Workshop, Bling-a-Birdhouse, Dino Roar, Dinosaur Gardens, Bad Art Afternoon, Mini Haunted Houses, Wood Ornament Workshop, and Beading Basics.

END OF THE SUMMER PIZZA PARTY

In 2021, St. Isidore Community Services hosted an End of the Year Pizza party at the St. Isidore Cultural Centre. Pre-teens and teens were invited to build their own pizza from scratch with their peers the Friday before school started.

HIGH FITNESS

St. Isidore Community Services partnered with a local fitness instructor to coordinate a youth inspired High Fitness Class. Participants were able to participate in a free, hour long fitness class geared towards youth. The goal of the program was to increase physical activity intake and to connect youth with their peers.

INDOOR/OUTDOOR HOCKEY PROGRAM

Indoor/Outdoor Hockey was offered in Cadotte Lake. When weather permits, the youth utilize the outdoor rink to play ball hockey and/or ice hockey. When the weather does not permit, indoor hockey is offered in the gymnasium at the Mamowintowin Hall. Hockey nights allow youth of all ages to be active in a controlled environment. The rules of the game are taught and everyone has an opportunity to play (all ages and abilities

YOUTH PROGRAMMING

MAKE & TAKE KITS

In 2021, Nampa/Northern Sunrise County Community Services coordinated several types of kits to keep children & youth engaged mentally while restrictions were in place, preventing them from coming together for a workshop or program. The kits provided in 2021 were as follows; Valentine crafts, New Year, New You, face care kits, rock painting kits, Mothers Day crafternoon, St. Patrick's Day green challenge, Easter crafternoon, Easter colouring contest, virtual kids crafternoon with a Zoom element, summer bucket of fun, and fairy & dino garden kits.

PARK PALS

Park Pals was developed in 2021 as a way to get families engaged at local parks, playgrounds, and greenspaces. The program was for families with children ages 0-5 years of age. Families were able to meet other families within the region while participating in activities that focused on gross and fine motor skill development.

READY, SET, GLOW

Nampa Community Services hosted a glow-in-the-dark themed day on a scheduled PD day, as a way to keep youth engaged and active on their day off. Participants participated in a variety of glow-in-the-dark themed activities, including capture the flag, keep the balloon off the ground, glow tag, and were also able to make neon slime to take home.

SCOOPS & HOOPS

In 2021, a Scoops and Hoops event was held at the Marie Reine Sports Court. The youth in attendance participated in a variety of basketball challenges, drills and games before enjoying homemade ice cream sundaes.

SPLISH SPLASH SPOTZ DAY

A water fun day was held in August for youth ages 8-15 in Marie Reine at the Cultural Centre. Participants were able to participate in a variety of water themed activities, including water balloon volleyball, water balloon basketball, plunger races, toss the water balloon, etc. In addition to the water activities, the Nampa Fire Fighter Association brought their fire engine and way jacks and coordinated a large scale water fight.

COMMUNITY PROGRAMMING

COMMUNITY KITS

Nampa/Northern Sunrise County Community Services coordinated a variety of activity kits throughout the year to enhance people's mental health and to provide a creative outlet while restrictions were in place. Participants were provided all supplies required, along with instructions on how to complete their craft project. In 2021, Community Services provided Sweet as Sugar bath bomb kits, Valentines Day activity bags, Hoppy Easter family activity kits, Indoor Herb Gardens, Egg-citing Easter goody bags, DIY Spring Yard Sign kits and birdhouse kits.

COMMUNITY WORKSHOPS

Nampa/Northern Sunrise County Community Services coordinated a variety of workshops throughout the year to encourage residents to connect with their communities and to socialize with others, all while learning a new skill or craft. Participants are able to take home their completed craft at the end of the program. In 2021, Community Services hosted a Dreamcatcher workshop, Spring Watering Can workshop, Iron on Wood project, Fresh Cut Flowers Sign workshop and Scrabble Wall Art workshop.

DERBY DAD DASH

In 2021, Nampa Community Services coordinated a kub car race for father figures and their little mechanics. Families registered to receive a kub car kit which had to be designed and decorated prior to a community race using a custom built kub car race ramp. Families took turns racing their custom cars for a chance to win.

FAMILY DODGE BALL

In 2021, St. Isidore Community Services coordinated family dodge ball evenings at the St. Isidore Cultural Centre Gymnasium. The goal is to get families active with one another and within their community.

FAMILY U-PICK DAY

Nampa Community Services sponsored a Family U-Pick at Meadowland Berries located just outside of Nampa. Families had the opportunity to pick haskaps and strawberries together to enjoy at home.

FROSTY FAMILY FUN DAY

In January 2021, St. Isidore Community Services partnered with St. Isidore Cultural Centre to host the annual Frosty Family Fun Day at the St. Isidore Skating Rink. Participants were able to skate, toboggan, enjoy roasting marshmallows over an open fire, and cups of hot cocoa. This event encourages families to get active together during the cooler months. It was held in partnership with the St. Isidore/Three Creeks Fire Fighter Association.

JUMP & JAM

In August 2021, Community Services partnered with the Economic Development Department to host a Jump & Jam event at Cecil Thompson Park. The event featured a local band, bouncy castles, and an open air market. Over the course of the event, there were approximately 400 people in attendance.

COMMUNITY PROGRAMMING

HALLOWEEN CELEBRATIONS

Halloween Celebrations were held in Cadotte Lake, Nampa, and St. Isidore in 2021.

Cadotte Lake hosted Trunk or Treat at the Mamowintowin Hall. The Trunk or Treat event gave residents an opportunity to decorate their car trunk or truck bed and hand out candy in the Mamowintowin Hall parking lot. There was approximately 200 people in attendance. All of the events held were in partnership with Woodland Cree First Nation.

Nampa Community Services partnered with Farmers Restaurant and the Nampa Museum to host Scarecrow Frenzy. Registered participants received stakes and were instructed to build a unique scarecrow. Scarecrows were put on display at the Nampa Community Garden and on Halloween, they were voted on.

St. Isidore Community Services partnered with the St. Isidore Cultural Committee to host a Halloween stop by event in the Cultural Centre parking lot. Participants received goodie bags and pre-wrapped hot dogs. There were approximately 115 participants that stopped by for a treat.

In addition to the Halloween themed events, a Halloween House & Lawn Contest was held. The contest allowed residents of Northern Sunrise County and the Village of Nampa to showcase their Halloween yard displays for a chance to win one of three prizes.

MARCHE FAMILIAL

In 2021, St. Isidore Community Services partnered with the St. Isidore Cultural Centre to host the annual Marche Familial (Family Run). Families are encouraged to walk, run, or push strollers along the pathways in St. Isidore. After the walk, participants are treated to pre-wrapped hot dogs and light refreshments.

NATURE WALK

Cadotte Lake hosted an interactive nature walk for families. Participants received scavenger hunt cards and received prizes for finding all the objects listed. In addition to the walk, participants were able to roast hot dogs and smores over a propane fire pit.

PRETTIEST PATIO CHALLENGE

In 2021, Nampa/Northern Sunrise County Community Services coordinated the Prettiest Patio Challenge. The challenge encouraged residents of Northern Sunrise County and the Village of Nampa to get into their yards to make a beautiful display of blooms for a chance to win a prize.

VIRTUAL WORKSHOP OPPORTUNITIES

Cadotte Lake Community Services coordinated a variety of virtual workshop opportunities throughout the year to enhance peoples mental health, knowledge and to provide a creative outlet while restrictions were in place. Participants were provided all of the supplies required along with a Zoom link. The virtual sessions offered were a Spring Wreath workshop, monthly Destination Cooking classes, and Flaming Halloween Craft Night where participants made a candle centerpiece using pool noodles.

SENIOR ACTIVITY KITS

Nampa/Northern Sunrise County Community Services coordinated two senior focused activity kits this year to enhance seniors' mental health and to provide a creative outlet while restrictions were in place. Participants were provided with all of the supplies required along with instructions on how to complete their craft project.

In 2021, I Wet My Plants was hosted by Nampa Community Services. Seniors received a kit to make a dog shaped wood planter along with potting soil and seeds.

Cadotte Lake Community Services put together Simple Home Maintenance Kits to ensure Seniors had tools to keep their homes updated.

REGIONAL PROGRAMMING

PADDLE THE PEACE

Paddle the Peace was first established in 2009 as an event where participants were able to paddle the mighty Peace River with lunch, transportation to the launch site, and safety sweeps provided. Paddle the Peace is the recipient of the 2014 Growing Rural Tourism Champion Award which honors outstanding accomplishments, innovation, and leadership in Rural Tourism. The event is coordinated by Northern Sunrise County, County of Northern Lights, Town of Peace River, and M.D of Peace. This year, Paddle the Peace reduced its participant numbers and split the entry into two waves in response to the pandemic. The event was held on August 15, 2021. There were approximately 100 paddlers registered for the group paddle down the Mighty Peace River. This is an annual event scheduled on the third weekend in August.

FRESH AIR CINEMA

In 2021, Nampa/Northern Sunrise County Community Services partnered with the Town of Peace River, Alberta Health Services Mental Health, Project Peace, Peace Regional Pride Society and Fresh Air Cinema to host an outdoor movie experience at the Peace River Agricultural Grounds. Two movies were shown on a large daylight screen; Up and Back to the Future. In addition to the movie, a variety of local food vendors were onsite serving fresh eats for participants. The event brought in around 325 participants.











Dear Minister:

Re: Bill 21 - Provincial Administrative Penalties Act.

The Town of Gibbons Council, at its January 12, 2022 meeting discussed a number of key issues that the Government of Alberta, two items that your ministry is specifically undertaking that are poised to fundamentally impact the lives of Albertans. The two key issues include the development of a Provincial Police Service (APPS) and Bill 21 - Provincial Administrative Penalties Act (Bill 21).

The citizens of Gibbons are proud, hardworking, dedicated, and reasonable family people who recognize that public safety is paramount, and that certain rights and freedoms may be contravened in times of disasters or pandemics for the sake of public good and done without consultation. One such example is that our citizens have for the most part, adopted the recommendations set forth by the Province during its response to the Covid-19 saga often without question.

There is however, times when citizens of Alberta must without exception, be consulted extensively in order to ensure that their voices are heard, respected, and play a significant role in creating the framework for the legislation (policy statement) being contemplated (i.e. APPS and Bill 21). Members of Council are scheduled to participate in the upcoming APPS consultations on February 1, 2022 and truly believe that should the Province be conducting these sessions without a predetermined decision in place, the concept of meaningful input from its citizenry will be realized and not just an exercise in placation.

It is the very process of inviting meaningful input from the citizens of Alberta or lack thereof of a formal consultation process in the development and adoption of the Bill 21 is why our Council is in firm opposition to its implementation without an amendment that reinstates a citizens ability to appeal traffic tickets in court versus making an application to appeal through an online submission. This erosion of due process represents one more step in the degradation of a citizens' rights and freedoms to a position where one should just "pay up" and then "shut up."



It is Council's hope that our society through the actions and policies of the Provincial Government has not become a society of where money is everything even at the expense of ones right to a sense of fairness and due process.

Provincial Administrative Penalties Act

Overview

The *Provincial Administrative Penalties Act*, 2020, will make our roads safer by introducing stronger and immediate impaired driving penalties and reducing the time it takes to enforce traffic and non-criminal impaired driving matters, to ensure impaired drivers are off the streets. It will restore critical capacity to Alberta's justice system by creating a streamlined, fast, fair and efficient method for resolving non-criminal impaired and traffic disputes to free up court time to prosecute serious criminal matters and ensure police are on the streets instead of doing paperwork or sitting in courtrooms.

Immediate Roadside Sanctions Program

The new Immediate Roadside Sanctions (IRS) Program will be introduced on December 1, 2020 and will provide a comprehensive array of serious, immediate and escalating consequences for impaired drivers—a system that has been proven to reduce impaired driving significantly in other jurisdictions. Consequences for drivers will include driver's licence suspensions, new fines, vehicle seizures, mandatory education, and participation in the Ignition Interlock Program (IIP).

Increased impaired driving consequences under the new IRS Program will include:

- Driver's licence suspensions;
- Fines of up to \$2,000;
- Increasing length of vehicle seizure up to 30 days;
- New mandatory education programs for repeat offenders; and
- Participation in the IIP for repeat offenders.

SafeRoads Alberta Branch

Most non-criminal, first-time impaired drivers will be able to deal with these penalties through SafeRoads Alberta, a new branch dedicated to providing a speedy method of resolving disputes. The new process will be significantly quicker, dealing with all matters in 30 days to ensure impaired drivers are off the roads, not the months or years it can take to go through the current administrative and court processes. Repeat offenders, impaired drivers who cause bodily harm or death, and other more serious cases will still receive criminal charges in addition to the other penalties.

In addition to saving lives and preventing needless injury, these new measures are expected to benefit Albertans in several other ways:

- Freeing up about 8 per cent of court time to ensure Alberta's prosecutors and courts can clear their multi-year backlog to prosecute serious criminal matters;
- Eliminating approximately 1,200 complex full, or multi-day trials; and
- Freeing up more than 30,000 hours of police time ensuring police are on the streets protecting Albertans and their communities.

This new impaired driving administrative model is based on changes made in British Columbia, which has seen many positive impacts, including:

- A 36 per cent drop in impaired driving incident rates from 2011 to 2018.
- A 54 per cent drop in number of impaired driving fatalities from 2010 to 2018.
- An 8 per cent reduction in hospital admissions even a modest decrease in emergency visits saves millions of dollars in critical capacity.
- A decrease in the median elapsed time for all types of cases (single or multiple charges), all offence types (including traffic) by 17 days from 2011-12 to 2018-19.
 - During the same time period, the median elapsed time increased by 16 days for Canada and by 7 days in Alberta.

This can include: A driver will also be arrested, detained for several hours to conduct further testing and be processed and then released with a requirement to return to court or face additional criminal charges. The individual must attend at one or more initial docket appearances and ultimately at a trial. The trial process is complex and generally requires expert assistance to navigate. Upon conviction a driver will receive a criminal punishment and a permanent criminal record.

Traffic Safety Violations

The *Provincial Administrative Penalties Act* also allows for other traffic contraventions to be resolved by SafeRoads Alberta. This new online system of dealing with non-criminal traffic offences will be introduced in late 2021 and will be easier and quicker for Albertans to navigate. SafeRoads Alberta will divert nearly two million traffic tickets from Alberta's courts, freeing up court time for criminal matters, ensuring law enforcement can spend more time on the streets and less in courtrooms for violations, and avoids the necessity for hundreds of thousands of Albertan's to visit courthouses merely to pay tickets or schedule hearings.

The resources currently devoted to managing these millions of tickets can then be dedicated to addressing serious justice matters and returning police to the community.

Dear Mayor Bulford and Village of Nampa Council,

As you might be aware, in January, the National Police Federation (NPF) launched the <u>KeepAlbertaRCMP</u> <u>Community Engagement Tour</u> to provide information and listen to Albertans about the provincial government's unpopular and wasteful plan to transition to a new provincial police service.

We are now just over half-way through our scheduled Community Engagement Tour, having completed three rounds of in-person events and three online sessions. We have visited twenty-two municipalities from Pincher Creek to Fort McMurray and met with hundreds of Albertans from all walks of life. From all these meetings, one thing is clear - Albertans want answers from their government and do not support this transition.

The Government of Alberta (GoA) has committed to making a decision about the future of the RCMP in Alberta this spring. However, the pressing concern that remains top of mind for the public is the limited options available to them to hear the government's presentation and have their questions answered. The GoA's sessions that are currently happening are only open to invited participants from municipal governments, and not to the general public or other groups, and we understand that even then, there are many questions the Alberta Justice team cannot answer.

If you have recently attended one of the GoA's APPS presentations and would like to share any of your thoughts and feedback with us, we would appreciate hearing it and being able to pass it along. This will allow us to let the public know what information is available to them through you, their elected officials. Albertans deserve answers to their questions and to understand why the government is proceeding with this unwanted idea.

A special thank you to all of you who have come out to our sessions so far, it has been great to talk with you about what this proposed transition might mean for your communities.
