Dear Village of Nampa

My name is Marie Dyck and I am in the President position for the Nampa and District Daycare Society. Our Society is working hard to create and develop a Daycare that will provide educational and stimulated learning from the ages of 1 years to 5 years, as well as offer an out of school program. We hope to have the staffing and structural needs identified and ready to accept children and students for September 1, 2023.

As a Society we have applied and received the Space Creation Grant which provides funds for the structural and environmental needs for our Daycare. We are in a partnership with the Nampa Seniors Drop in to use their space to operate our Daycare. The Space Creation Grant is not an operational grant, and the only operational grant in Alberta that would serve our needs is the Community Initiative Program where we could apply for an operational grant. However, we are not eligible for this grant until we have been established for a full year, and we only received our Registered Society Status in April 2023. That is why we are asking for your help.

As elected leaders of our community, you must know how difficult and costly Daycare operations like ours can be. With the resources Village of Nampa has and your incredible history of supporting not for profit work that improves the quality of care and education for children, I know that together we can make a huge difference.

Our philosophy is that children are unique individuals who deserve a warm, secure environment that promotes a sense of wonder and discovery in learning. We encourage children to develop socially, physically, intellectually, creatively and emotionally as they grow. We value an environment that respects the distinctive qualities of others and individual aspect of themselves. We partner with parents and the community to enhance the child's growth and development. Our Mission Statement: The Nampa and District Daycare provides a planned play program in a warm, accepting, safe environment. We have age appropriate activities that stimulate physical, social, emotional, intellectual and creative growth. This builds confidence for future life experiences for every child. Our Vision Statement: The ultimate vision we have for our facility is rooted in both the present and the future. For the present, our goal is for parents to feel secure about their childcare choice, and that the children are safe, engaged, educated, and smiling. And for the future, we want these children to fondly look back at their experience with us and see it as a cherished part of their childhood.

We are asking the Village of Nampa to provide 10% of operating dollars of 3months of funding that will provide staffing dollars for Child Educators, contracted services (maintenance/housekeeping and bookkeeping, rent for the year, and other services. We have attached a proposed budget that totals:

Staffing and wage expenses for 3 months: 58195.98 - 10% = 5819.60

Program and contracted expenses for 3months: 14009.01 – 10% = 1400.90

After the first 3 months we should be able to supplement the costs the daycare fees and Government of Alberta Subsidies and Wage top ups. We'd be happy to provide an incentive, for example: we will thank

you publicly, put your Village's name on our website or on event literature in exchange to show how much we appreciate your support.

I am happy to present our proposed funding request at a future Village of Nampa meeting. Our society has also attached our program plan, proposed annual budget and parent handbook and policies to allow you to review the work that the Society has been putting in over the last 6 months in preparation for the Daycare success.

Re: Emergency rural bus line support

Congratulations on your re-election and your re-appointment to the position of Minister of Transportation and Economic Conditions. Now that the election and cabinet appointments have been completed, I write in response to your letter of January 16 of this year. In it, you indicated that your department is evaluating the 2018 Rural Transportation Pilot Program to determine 'Next Steps' for rural transportation in Alberta. I hope that the intervening six months have been sufficient to assess the situation and identify solutions.

Because, as Alberta's largest rural bus network (and the only major system which is Albertan owned), I bring to your attention the serious threat to Alberta's rural bus services. My company, Cold Shot bus lines, continues to provide bus services to rural Albertans in 24 municipalities in some 65 constituencies. Our operations serve the far reaches of the province—the so-called "milk runs", as opposed to the "cream runs" between larger centres which are operated by major corporations headquartered in Quebec and Saskatchewan. When others were getting awarded funding, cold shot wasn't even got acknowledged by our own Alberta Government.

Despite the massive rise in costs brought on by post-COVID inflation, we continue to provide the best possible service at the best possible prices. Our prices remain stable, but unless we receive support, we will not survive long enough to participate fully in the recovery from COVID—already, we have had to reduce our routes from 11 to 6.

Further, if Alberta's largest rural bus company is allowed to fail, the cost and the effort to replace us will be prohibitive, amounting to the removal of an essential service. How will rural Albertans cope without our service?

According to the Alberta government policies under your predecessor, we are a 'for-profit' enterprise, which justified them in turning down repeated requests for assistance. But for the almost three years where we were not turning a profit—in fact, for two years during COVID, we lost money on every bus which we sent out—we sourced financing to keep providing rural bus services which we have now exhausted.

Therefore, I request that you review your government's policies in light of the damage done by COVID, and the ongoing impact of Inflation.

Honourable Premier Danielle Smith forwarded your letter of November 28, 2022 alerting the province of the challenges Cold Shot bus lines continues to face in providing bus services to rural Albertans in 67 municipalities in 65 constituencies. As Minister of Transportation and Economic Corridors, I am able to provide the following information.

Thank you for your dedication and commitment to help rural Albertans meet their transportation needs and improve access to education and health services, and employment opportunities. There is no provincial program to fund private bus companies; however, Transportation and Economic Corridors acknowledges the private intercity busing industry is a critical backbone of the transportation system for individuals who live in rural and remote communities without access to transit options, and who would otherwise be left without access to essential services. In recognizing this, earlier in the year the previous Minister of Transportation and Economic Corridors urged the federal government to consider providing greater support for this industry by expanding eligibility under the Rural Transit Solutions Fund.

In 2018, Transportation and Economic Corridors launched the Rural Transportation Pilot Program, expanding bus services in six rural areas across the province. The department is evaluating the program in order to determine next steps for rural transportation in Alberta. Transportation and Economic Corridors will continue to work with rural municipalities to hear concerns and consider options to support public transportation for rural residents.

Dear Premier Smith:

Re: Emergency rural bus line support

Congratulations on your becoming Premier of Alberta. I write to alert you to a serious threat to Alberta's rural bus services, and to request loss relief that will enable my company, Cold Shot bus lines, to continue providing bus services to rural Albertans in 67 municipalities in some 65 constituencies.

When Greyhound abandoned Alberta in 2018, Cold Shot took on 11 routes, becoming Alberta's largest rural bus network with the lowest prices amongst all inter-city transport companies. Our operations serve to the far reaches of the province—the so-called "milk runs", as opposed to the "cream runs" between larger centres.

Now, Inflation has replaced COVID as a threat to our operations. Fuel costs in February amounted to \$53,000.; in September, we paid \$90,000. These aren't the only increases, and as the sole transportation option for many rural passengers who can't afford vehicles—Seniors, First Nations, and workers travelling to camp jobs—we are their lifelines. They need to travel for the post-pandemic recovery. What will these marginalized people do if we cease serving them?

Despite the massive rise in input prices, we continue to provide the best possible service at the best possible prices. Our prices remain stable, but unless we receive support, we will not survive long enough to participate fully in the recovery from COVID—already, we have had to reduce our routes from 11 to six.

If Alberta's rural bus companies are allowed to fail, the cost and the effort to replace them will be prohibitive, amounting to the removal of an essential service. How will rural Albertans cope without rural bus service?

According to the Alberta government policies under your predecessor, we are a 'for-profit' enterprise, which justifies them in turning down repeated requests for assistance. But for the almost three years where we were not turning a profit—in fact, we were losing money—we sourced financing to keep providing rural bus services. All, while the policy of 'let market forces decide'—which was applied during COVID, but hopefully won't be continued in the face of Inflation.

Therefore, I request that you review your government's policies in light of the damage done by COVID, and the ongoing impact of Inflation.

Also, I respectfully ask that your government provide loss relief to enable us to weather the final stage of the pandemic, and to survive the current Inflationary pressures. Based on current expenses, we project that our fixed bus operating costs will amount to a daily amount of \$13,229 for driver wages, insurance, fuel, maintenance, and cleaning—to a 12-month total of \$3,382,848.9 million. Rather than ask for a lump sum, I suggest that funds be

provided quarterly, whereby we deliver a transparent accounting of our operating expenses. I will point out that any funds received would be allocated to operating expenses, not debt servicing, or overhead expenses.

If you decide that your government will assist Cold Shot in maintaining services, we would be pleased to cooperate with any form of media announcement. We would also be willing to post notices in our buses and facilities, apprising our rural customers that, "This bus is operated through the support of the Government of Alberta", or verbiage of your choice.

RE: Imminent Demolition/Transfer of Ownership of Buildings at Northwestern Polytechnic, Fairview Campus

It has come to the attention of the Council of the M.D. of Fairview No. 136 that Northwestern Polytechnic is planning to proceed with the imminent demolition/transfer of ownership of a significant number of buildings at its campus in the Town of Fairview.

The viability of the NWP Fairview Campus is vital to the economic stability and health of the region, including the M.D. of Fairview No. 136. These concerns have been expressed to NWP President, Justin Kohlman and the previous Minister of Advanced Education, Demetrios Nicolaides. Further, at the December 13, 2022 Council Meeting, NWP President, Justin Kohlman agreed to be transparent with and inclusive of the M.D. of Fairview No. 136 in relation to any plans of NWP to downsize its Fairview Campus – he has failed to do so. In fact, public engagement regarding significant changes to a key local economic driver has been sorely lacking. The NWP Fairview Community Advisory Committee, of which two municipal councillors are members, has been largely inactive for quite some time and has not been informed by NWP of its plans.

M.D. of Fairview No. 136 Council is firm in its commitment to continue to advocate for increased utilization of the NWP Fairview Campus. Intentional reduction of facilities to increase learning environment utilization percentages is worrying and allegedly, is the key to obtaining additional provincial grant funding. Council is concerned that NWP's plans are not indicative of an intention to ensure long-term success of the Fairview Campus. Rather, it appears to be a slow death by a thousand cuts, of a vibrant and regionally important educational institution.

The planned demolition/transfer of ownership of buildings is slated to occur imminently – potentially within the next month. Council is requesting your support in urging NWP to:

- Be transparent and communicative with neighbouring municipalities of its true intentions relating to its Fairview campus;
- Exercise restraint and be conscientious of the impact its decisions have on neighbouring municipalities; and,
- Be open to seeking alternative solutions to demolition/transfer of ownership. Additionally, Council is requesting clarification from the Provincial Government whether learning environment utilization percentages is a key determinant of provincial grant funding.

Lastly, Council is requesting a meeting with you, as Minister of Advanced Education, and with the Honourable Todd Loewen, MLA for Central Peace-Notley, to discuss the future of NWP, Fairview Campus.

North Peace Housing Foundation Board Meeting Synopsis – June 7, 2023

1. Executive Director

Wildfire Update

On Friday, May 5, we received a call from staff at the Homesteader Lodge stating that there were houses on fire in Hines Creek and there was concern for the Lodge. At that time, we had not received any notifications to be on watch or evacuation alerts regarding the wildfire that was classified as being out of control in Clear Hills County. The Foundation, in consultation with Home Care, made the decision to evacuate 10 Homesteader Residents and 1 Tenant from the Pioneer Village in Worsley to Heritage Tower Lodge in Peace River, as there was enough room to accommodate all evacuees. One Resident chose to evacuate to Fairview.

Late afternoon on Saturday, May 6, we received word that there was a fire just outside of the Town of Fairview that was a cause for concern; at that time, the Town was on watch and some areas were being evacuated. Family contacts were called and asked to collect their loved ones, while the remaining Residents were on standby in the dining room. 43 Residents went home with family, 4 were in hospital, 1 was away, and 13 were on standby. We made the call to evacuate the Lodge and had the Residents on the road to the Heritage Tower Lodge by 7:50 pm. Shortly thereafter the evacuation order and alert for the Town of Fairview was lifted. Evacuees were notified that they were able to return home, however residents of Fairview were asked to remain vigilant.

The decision was made to continue with the evacuation as planned, due to the time required to fully evacuate the Lodge and anticipating that there was the potential to go through the same scenario if the winds picked up or shifted.

Ten Residents were evacuated to the Heritage Tower Lodge and 3 Residents stayed at the Sawridge Hotel in Peace River. All available rooms at the Heritage Tower Lodge were full.

On Sunday, May 7, Homesteader and Harvest Lodge Residents were happily headed home once it was determined that there was no risk to the Residents and that the gas was turned back on at the Homesteader Lodge.

On May 15, the Foundation was contacted by Heart River Housing to see if we had availability to accept 5 individuals from the Red Willow Lodge in Valleyview. Later that evening, we welcomed 4 residents and 1 staff member. The 5 evacuees stayed with the Foundation until Thursday, May 18, when it was determined that they could return home safely.

In all cases, Heritage Tower Lodge staff went above and beyond to get rooms ready for the evacuees and did an exceptional job making their visitors feel welcomed.

Asset Transfer

The Asset Transfer agreements have been fully executed and are now considered final. The Foundation anticipates that we will be receiving the first payment of the Capital Maintenance Reserves in the upcoming weeks.

Nominal Sum Properties

Although there is ongoing interest in the properties, we have not yet received any offers. However, there is a specific property in Grimshaw that requires attention before we can resume advertising it for sale. During a recent showing, it came to our attention that the house may have foundation issues that need to be addressed. We will continue to investigate.

Sustainable Remote Housing Initiative (SRHI) - Cadotte Lake Trailers

Upon thorough investigation, we have determined that one of the units that experienced complete freezing over the winter is indeed salvageable. While the hot water tank and toilet will require replacement, we are pleased to report that no additional damage or water leaks have been identified.

Westview Development

The Westview Development Ad Hoc Committee was created by Board Motion at the May 3, 2023, meeting. Information about the existing Westview Development plan will be shared with the Committee in the upcoming weeks.

Del-Air Lodge Redevelopment

As of May 26, 2023, asphalt shingles are approximately 45% done; framers are working on the last shed roof and finishing the flat roof; drywallers will be starting next week; crews are working on concrete on the front entrance and the back sidewalk; additional site work is being done, as well. Windows are currently being installed.

Chandos is working on finding a contact for TELUS, as an old pole needs to be removed after TELUS remove their connections.

JMAA is to provide Chandos with updated renovation drawings due to several unforeseen factors that required careful consideration.

Completion date is scheduled for February 2024.

Garden Court Irrigation System

The installation of the irrigation system is nearing completion, with only the electrical work remaining to be done. Once the electrical work is completed, the system will be fully operational. The final phase of the project will involve the necessary grounds work, including the addition of topsoil where required, seeding, and implementing weed control measures.

Heritage Tower HVAC System Replacement

- The Foundation is pleased to announce that we have hired a student for the Summer Student –
 Maintenance position. Jackson McGillivray is the newest member of the Maintenance team.

• We are currently advertising for the Summer Student – Admin position and have started to receive applications.

Board Actions and Decisions

The Board directed Administration to contact ACSSI North Inc. to obtain quotes for the replacement of the nurse call systems for Harvest, Homesteader, and Heritage Tower Lodge, with the focus on Harvest Lodge for replacement in 2023.

The Board directed Administration to move forward with the proposed siding replacement for the existing Del-Air Lodge and garage for a combined cost of \$120,621.00, plus GST.
